SERVICES PROVIDED & ELIGIBILITY REQUIREMENTS

The Religious Coalition for Emergency Human Needs provides programs and services to Frederick County residents in need.

EMERGENCY SHELTER

Alan P. Linton, Jr., Emergency Shelter

Homeless adults, 18 years of age or older

Operates: Year-Round, 7 days/ a week

Walk-Ins Admitted: 6:30-9:00pm

Closes: 7:00am

Emergency Family Shelter

Homeless families for adults, 18 years old and older, with minor children.

Parents/Guardians must have sole physical & legal custody of children

Operates: Year-Round, 24 hours/day, 7 days a week

Apply in person

Intake application is required.

HOMELESS PREVENTION

Rental Assistance

Assistance to Frederick County residents who are facing eviction.

We do not assist with regular rent payments.

Must provide court ordered eviction notice or rent court notice.

Clients must be able to pay the next month's rent.

Security Deposit

Assistance with security deposit for Frederick County residents who are imminently or currently homeless.

Must be county residents prior to applying for assistance.

Must provide rental agreement/pending lease.

Clients must be able to pay the next month's rent.

Energy Assistance

Assistance to Frederick County residents who are facing or experiencing active utility termination. This program runs mid-April through the end of November with a termination notice. From November 1-March 31, assistance will be provided to those that have had their utilities completely terminated or for fuel oil needs.

Assistance is provided for utilities with termination notices only and does not assist with security deposit for utilities or with bills that are simply due.

Must apply at DSS prior to requesting assistance.

Termination notice (applicant's name must be on the notice).

Clients must pay a portion of their bill.

HEALTHCARE

Prescription Assistance

Assistance with general medications and psychiatric medications for the uninsured. Provided on an emergency basis. *We do not provide assistance for controlled substance/narcotics.*

Must have active prescription or available refills.

Must apply for any eligible healthcare programs.

Prescription must be current and include the name of drug, dosage, quantity and supply indicated.

Dental Assistance

Assistance is provided to clients who are in active dental pain. Our dental providers, provide simple dental procedures, such as an extraction or filling. They do not provide root canals, cleanings, or dentures.

Clients must fall under the income requirements to be eligible. Limited funding. First come-first served basis.

Eyeglass Assistance

Assistance is provided by Lion's Club.

Must complete application and provide income verification.
